Cancellation Policy

For members who desire to withdraw from participation after payment, the following rules shall apply:

- a) All cancellation requests must be received in writing. The email should be sent to chairman@ican-malaysia.org, iadams@ican.org.ng and faolawuyi@ican.org.ng
- b) Refund of 100% of fees paid, less administration charge (\$200), will be returned on request if cancellation is thirty days or more before the event.
- c) Refund of 50% of fees paid, less administration charge (\$200) will be returned on request if cancellation is made between fifteen and thirty days before the event.
