Visa processing will be handled by the Malaysian High Commission in Abuja, Nigeria via the online visa application. Therefore, you must take advantage of early bird registration possibilities to improve your chances of having your visa approved by the Malaysian High Commission in Abuja, Nigeria. Nigerian nationals seeking entry into Malaysia must apply together with the necessary documents. If the application is accepted, you will receive an email with your visa.

5.0 Cancellation, Deferrals and Refunds Policy

For members who desire to withdraw from participation after payment, the following rules apply:

- a. All cancellation requests must be received in writing. Email should be sent to: chairman@ican-malaysia.org and info@ican-malaysia.org; iadams@ican.org.ng and sabalogun@ican.org.ng
- b. Refund of 100% of fees paid, less administration charge (\$200), will be returned on request if cancellation is thirty days or more before the event.
- c. Refund of 50% of fees paid, less administration charge (\$200) will be returned on request if cancellation is made between fifteen and thirty days before the event.
- d. No refund will be made if cancellation is less than fifteen days before the event.
- e. Refunds (less administrative charge of \$100) to delegates denied Visa would be made 60 working days after the Conference.
