## 3.0 Submission Guidelines

- Submit abstract or full paper with evidence of conference fee deposit slip or payment transfer
- The paper must be original and have not been previously accepted in a journal or under consideration for publication elsewhere
- All papers must conform to the standard single-column format set in MS Word Template ([Download it HERE](#))
- The paper must be written in English with a maximum of 10 single-spaced pages, including an abstract, references, tables, figures and appendices
- Any additional page will be charged USD 20 per page
- Abstract without the completed paper will NOT be accepted.
- Papers must be sent through the **OpenConf Peer Review and Conference Management System**.

Papers for the presentation at the conference will be selected through a double-blind peer-review process. Please ensure that the authors' names do not appear in the first submission.

At least one author for each accepted paper must register and pay the fees for the conference by 18 March 2024 for the paper to be included in the Program and the Conference proceedings. By submitting a paper to present at the ICAF-IMDS Kuala Lumpur 2024, you explicitly agree that you will have a fund and shall register for the conference.

## 4.0 Publications/Proceedings/ISSN/Indexing

### 4.1 Proceedings

Accepted papers will be published in the Conference Proceedings. Authors will be required to transfer the copyright of their paper to ICAF-IMDS Kuala Lumpur 2024. The Proceedings will be available in the ICAF-IMDS Digital Library which can be accessed online, and will also be available in hard copy after the Conference. The Proceedings will be sent to ISI Thomson and Scopus for indexing.

### 4.2 Journal

Based on the recommendations provided by the peer reviewers, quality papers will be considered for publication in the following refereed journals:

- ICAF-IMDS Conference Proceedings.
- Indian-Pacific Journal of Accounting and Finance (IPJAF);
- International Journal of Contemporary Accounting Issues (IJCAI);
- Publication in Scopus/ERA

The accepted papers are subject to compliance with review reports, editorial comments, conference feedback, and payment of applicable submission fees. Before submission, papers need to be formatted as per the journal requirements. Authors of the shortlisted papers will be invited to enhance their papers (i.e., improving the findings, expanding in some areas and drilling deeper into others, to justify a good journal publication) for submission and possible publication in the relevant journals. Papers will undergo the journal's peer review process, and the journal's Editors will select accepted papers for publication.
